

WASHINGTON-ON-THE-BRAZOS RULES AND REGULATIONS

1. All booths must be set up by 10:00 a.m. Set up is preferred to be completed on Friday evening. No late arrivals or setups allowed after noon. **Please check with Park Headquarters personnel for exact booth location before attempting to enter food booth areas.**
2. All booths must remain open until closing time.
3. No changes of booth space will be made during the Celebration.
4. Do not attach anything to buildings, walks, road surfaces or any part of Washington-on-the-Brazos State Historic Site.
5. No motor homes or trailers attached to booths will be allowed.
6. Each exhibitor is responsible for collection and disposal of booth trash.
7. Vendors must park their vehicle in designated Vendor Parking Area. **This will be strictly enforced—if in violation, vehicle will be towed.**
8. The booth fee – for one food booth - of \$195.00 is non-refundable. **If your application and fees are received by November 21, 2014 the booth fee will be \$175! Remember booth space is limited and is awarded on a first come first serve basis.**
9. Electricity is NOT available.
10. Booth spaces are assigned to approved applicants on a first come basis.
11. You may only sell food items that you list on your application. To insure profitability to all vendors – each food item is limited to one vendor.
12. Nearest water faucet is approximately 75 yards away. No ice is provided on site.
13. Coca-Cola is a major sponsor this event and we ask that only Coke products be sold. For your convenience a Coca-cola representative will contact you to see if you would like to pre-order products at a reduced rate.
14. **THE SIGNED APPLICATION IS INDICATES THAT YOU AGREE TO FOLLOW THE ABOVE RULES.**

- The signed application and booth fee must be received by May 31, 2015. Booth spaces are assigned to approved applicants on a first come basis.
- To reduce conflict, each food item is limited to one vendor.
- Please list on the application each item you wish to sell.
- If you choose to honor volunteer lunch tickets (issued only by Washington-on-the-Brazos State Park Association) you will be reimbursed at the set rate of \$4.00 per ticket.
- To be reimbursed, please count tickets, place tickets in a sealed envelope, write attn: Ginger Moreland on the outside of the envelope. You will need to turn these tickets into the Park staff in the Visitors Center prior to 8:00 pm.
